Summary of country engagement at SWA

Pakistan joined SWA in 2010. The Ministry of Climate Change represents the Government of Pakistan in SWA, and it also runs the Clean Green Pakistan program, a priority of Prime Minister Imran Khan. Access to safe drinking water, total sanitation, wastewater treatment, solid waste management are four pillars out of the five key areas of the Clean Green Pakistan Program. Pakistan has a devolved government system in which implementation of activities in water, sanitation, and hygiene occur at the provincial level. Pakistan is a pioneer country for the SWA Mutual Accountability Mechanism. The Government of Pakistan tabled the Clean Green Index program to track the performance of city local government as a commitment. Under the Index a formal government-led multi-stakeholder review mechanism is in place to assess progress regularly. The mechanism applies evidence-based decision-making, including consideration of agreed indicators (e.g., access, WASH-related disease, WASH finance). Routine monitoring and reporting include disaggregation for assessing inequalities and an effective tracking mechanism for WASH.
