Summary of country engagement at SWA

Rwanda joined SWA in 2010. The Government's primary vision for WASH sector is to progressively achieve safely managed water supply and sanitation services for the socioeconomic development of all Rwandans. It has an ambitious target of reaching universal access to basic and safely managed water supply and sanitation services to all Rwandans by 2024 and 2030 respectively. The country believes that these targets will be achieved through the provision of improved, extended and sustained water supply and sanitation services; enhanced standardization; more innovative technological options and enhanced enabling environment for the WASH sector.
