# Introduction

## Dear participant,

The SWA Secretariat looks forward to welcoming you to the 2022 Sector Ministers' Meeting. In this Logistics Note, you will find information that we hope will make your travel and stay in Indonesia pleasant and trouble-free. It includes details about health protocol, visas, accommodation, transport, and other useful information.

The upcoming <u>Sector Ministers' Meeting (SMM)</u> is scheduled to take place on 18-19 May 2022 and will be hosted by the Government of Indonesia, and co-convened with SWA's global partner, UNICEF. Building on previous <u>SWA High-Level Meetings (HLMs)</u>, the SMM is a critical opportunity to foster linkages between the water, sanitation, and hygiene (WASH) sector and other sectors, with a view towards elevating the prioritization of WASH across national policies.

The SMM will be a forum for ministers responsible for water, sanitation, and hygiene, together with ministers responsible for the environment, and other relevant ministers, to meet and to review WASH related policies and commitments to ensure that climate action, health, and economic recovery considerations are well integrated. Following the decisions and commitments that will be made at COP26 in Glasgow, UK, in November 2021, the meeting will be an important occasion to ensure alignment across sectoral policies, using the <a href="SWA framework">SWA framework</a>, and <a href="the the "Mutual Accountability Mechanism">the "Mutual Accountability Mechanism"</a> as a tool for stakeholders to come together and jointly review commitments and progress.

# **Health Protocol**

With the COVID-19 context constantly evolving, a full health protocol will be shared with participants separately to inform you about the mandatory requirements prior to arriving in Jakarta, at arrival, during the meeting and prior to departure from Jakarta.

## **Accommodation**

The SMM will take place in an event area in the Swissôtel Jakarta PIK Avenue.

More information regarding the venue will be provided to participants with the Welcome Pack.

To meet the requirements for the meeting, we are asking all participants to book in the Swissôtel Jakarta PIK Avenue, where the SWA Secretariat has pre-reserved a limited number of rooms. Participants will be responsible for arranging their own accommodation at the hotel, but they should indicate that they are there for the SMM.

The final agreed room fee will be informed to all participants by 25<sup>th</sup> April,2022. We will also share a link for booking of rooms at Swissotel by 25<sup>th</sup> April,2022.

# **DSA**

SWA Sponsored participants will receive per-diem (DSA) to cover transportation, meals and hotel accommodation.

# **Travel**

#### Pre-arrival

According to current regulations, all participants must be fully vaccinated (two doses) at least <u>14 days</u> prior to departure and have a <u>negative</u> PCR test at least 48 hours prior. Participants not eligible for COVID-19 vaccination due to underlying health conditions require a doctor's statement.


This service is dedicated to verifying foreign-issued, vaccination cards that will be used to accommodate your activities in Indonesia through your <u>PeduliLindungi</u> application.

#### Arrival

Quarantine protocol was lifted as of 23 March 2022. An RT-PCR test may be administered upon arrival at the airport. Participants are required to do an RTPCR within 48 hours before departure for Jakarta







## **Travel Insurance**

Travel Insurance will be necessary to obtain a visa for Indonesia. Obtaining travel insurance will be the responsibility of the participant. When buying your insurance, please be sure it covers these two items:

- Insurance with a minimum coverage of USD 25,000
- Coverage for anything related to COVID-19 and medical evacuation to the referral hospital in Jakarta

#### Visa

Due to upcoming holidays in Indonesia, all Indonesian Embassies will be closed from 29 April to 9 May 2022. For this reason, **all participants are required to use one of the options stated in this note to obtain a visa.** This includes participants in countries with Indonesian embassies regardless of the type of passport. ### Who needs to apply

Visa on Arrival is permitted for participants in the following categories:

- Holders of Diplomatic or Service passports or UNLP from any of the countries being invited to the SMM
- Nationals of 43 countries listed in Annex A regardless of type of passport

#### E-visa

#### Who needs to apply

E-visa is available for participants traveling on their national passports and whose country is NOT on the list of 43 countries in Annex A.

#### Documents to be submitted by 28 April to the SWA Secretariat

- Passport bio page (\*Note- the passport must have a minimum validity period of 6 months prior to e-visa submission)
- Itinerary or air ticket (\*Note- this will be generated by SWA if the traveler is sponsored by SWA)
- Signed statement letter stating the person's willingness to comply with health
  protocols in Indonesia and willingness to cover any health costs which arise
  independently. Each traveler is requested to use the statement in Annex B to fill in
  their details, sign the statement letter in and return a copy to the SWA Secretariat.
- · Passport photo in color with white background
- Vaccination certificate and make a verification through this link: https://vaksinln.dto.kemkes.go.id/user. (\*Note- people who are not fully vaccinated need to bring a doctor certified statement exempting them from vaccination.)

Government participants without Embassies in Jakarta as well as other SMM participants will receive transportation through the Bluebird company.

## **General Information**

#### **Jakarta**

Jakarta is the capital city of Indonesia, located in the northwest part of Java Island.







#### Climate

During the month of May, Indonesia is in the dry season. In Jakarta, the temperature ranges from an average high of 31.2°C (88.2°F) and an average low of 26.1°C (79°F).

#### **Dress Code**

The dress code for the meeting is formal business attire.

#### **Time Zone**

Local time in Jakarta is Western Indonesian Time (GMT +7)

# Working language and interpretation

The SMM will be conducted in four languages, English, French, Portuguese and Spanish.

# International dialing codes

Indonesia's country code is +62, and Jakarta's local code is +6221.

# **Electricity supply**

All power sockets in Jakarta provide a standard voltage of 220V with a standard frequency of 50Hz with plug types Cand F.



# **Currency and banking**

The currency in Indonesia is the Indonesian Rupiah (Rp or IDR). All transactions in Indonesia require the rupiah as the legal tender. Authorized money changers and ATMs are available at the airport and meeting venue.

# Photography & Videography

The 2022 Sector Ministers' Meeting will be documented and streamed live on the Sanitation and Water for All (SWA) website. Delegates may be filmed or photographed. Photos and videos may also be available on the SWA website after the event.





# **Tipping**

Tipping is optional in Indonesia. However, service charges (5-10%) may occasionally be applied to hotel and restaurant bills.
